# COVID-19 guide for parents of children going to school or childcare - children with symptoms part 1

Your child has one or more of these COVID-19 symptoms that are new, getting worse or not related to other known causes:



**Note:** Chronic symptoms that can be explained by a pre-existing medical condition (such as allergies) are considered as part of your child's baseline health.

As long as these symptoms don't change, your child can go to school or childcare. Your child should have one negative COVID-19 test to set this baseline.



Your child **must** stay home and <u>isolate</u> for at least **10 days from the start of symptoms**.

<u>Household contacts</u> of your child who are **not** fully immunized should <u>stay home</u> for 14 days from the last time they had close contact with your child.

<u>Household contacts</u> of your child who **are** fully immunized are not required to stay home as long as they have no COVID-19 symptoms.

## What to do

Your child is no longer legally required to isolate, but should stay home from school, childcare and other public spaces until they feel better.


- · chills
- sore throat or painful swallowing
- runny or stuffy nose
- · feeling unwell or very tired
- feeling sick to their stomach (nausea) or vomiting or diarrhea
- · unexplained loss of appetite
- · muscle or joint aches
- headache
- pink eye (conjunctivitis)

**Note:** Chronic symptoms that can be explained by a pre-existing medical condition (such as allergies) are considered as part of your child s baseline health.

As long as these symptoms don't change, your child can go to school or childcare. Your child should have one negative COVID-19 test to set this baseline.

#### **Advice**

Your child should not go to school or childcare if they are feeling unwell



#### What to do

Your child **must** stay home and <u>isolate</u> for at least **10 days from the start of symptoms**.

- it has been at least 24 hours since the symptoms started

## COVID-19 ALBERTA HEALTH DAILY CHECKLIST (FOR CHILDREN UNDER 18)

#### Overview

This checklist applies for all children, as well as all students who attend kindergarten through Grade 12, including high school students over 18. Children should be screened every day by completing this checklist before going to school, childcare or other activities. Children may need a parent or guardian to assist them to complete this screening tool.

If your child has traveled outside Canada in the last 14 days, follow the <u>Government of Canada Travel</u>, <u>Testing</u>, <u>Quarantine and Borders</u> instructions, including any requirements for exempt travelers related to attending high-risk environments.

If within the last 10 days, your child has been notified by Public Health that they are a case<sup>3</sup> of COVID-19, they are required to isolate as per Public Health instructions.

#### Screening Questions for Children under 18:

1.	Has your child been a household contact of a case <sup>2</sup> of COVID-19 in the	YES	NO

	A household contact: a person who lives in the same residence as the case OR who has been in frequent, long-duration, close-range interaction with a case of COVID-19.		
	For example, siblings, someone who slept over, or someone who provided direct		
	physical care to the child.		

#### If the answer is "YES" AND they are NOT fully immunized4:

• Child should stay home and NOT attend school, childcare and/or other activities for 14 days from the last day of exposure and monitor for symptoms. If your child has symptoms, proceed to question 2.

#### If the answer is "NO" to question 1, proceed to question 2

2. Does the child have any new onset (or worsening) of the following core symptoms:

## If the answer is "YES" to any symptom in question 2:

- The child is required to isolate for 10 days from onset of symptoms as per the current <u>CMOH Order</u> OR receive a negative COVID-19 test and feel better before returning to activities.
- Use the <u>AHS Online Assessment Tool</u> or call Health Link 811 to arrange for testing and to receive additional information on isolation.

If the answer is "NO" to all of the symptoms in question 2, proceed to question 3.

Without fever, not related to being outside in cold weather		
Sore throat/painful swallowing	YES	
Not related to other known causes/conditions, such as seasonal allergies or reflux		
Runny nose/congestion	YES	
Not related to other known causes/conditions, such as seasonal allergies or being outside in cold weather		
Feeling unwell/fatigued	YES	
Lack of energy, poor feeding in infants, not related to other known causes or conditions,		
such as depression, insomnia, thyroid dysfunction or sudden injury		
Nausea, vomiting and/or diarrhea	YES	
Not related to other known causes/conditions, such as anxiety, medication or irritable bowel		
syndrome		
Unexplained loss of appetite	YES	
Not related to other known causes/conditions, such as anxiety or medication		
Muscle/joint aches	YES	
Not related to other known causes/conditions, such as arthritis or injury		
Headache	YES	
Not related to other known causes/conditions, such as tension-type headaches or chronic		
migraines		
Conjunctivitis (commonly known as pink eye)	YES	

#### If the answer is "YES" to ONE symptom in question 3:

- Keep your child home and monitor for 24 hours.
- If their symptom is **improving** after 24 hours, they can return to school and activities when they feel well enough to go. Testing is not necessary.
- If the symptom **does not improve or worsens** after 24 hours (or if additional symptoms emerge), use the <u>AHS Online Assessment Tool</u> or call Health Link 811 to check if testing is recommended.

## If the answer is "YES" to TWO OR MORE symptoms in question 3:

- Keep your child home.
- Use the AHS Online Assessment Tool or call Health Link 811 to determine if testing is recommended.
- Your child can return to school and activities once their symptoms go away as long as it has been at least 24
  hours since their symptoms started.

## If the answer is "NO" to all questions:

• Your child may attend school, childcare and/or other activities.

**Please note:** If your child is experiencing any symptoms from the lists above, do not bring them to visit a continuing care or acute care facility for 10 days from when symptoms started or until symptoms resolve (whichever is longer), unless they receive a negative COVID-19 test result and feel better.

## COVID-19 ALBERTA HEALTH DAILY CHECKLIST (FOR ADULTS 18 YEARS AND OLDER)

#### Overview

This tool's purpose is to support Albertans in protecting others and reducing the risk of transmission of COVID-19. Adults 18 years and older can complete this checklist every day to self-monitor for symptoms of COVID-19.

If you have traveled outside Canada in the last 14 days, follow the <u>Government of Canada Travel, Testing</u>, <u>Quarantine and Borders</u> instructions, including any requirements for exempt travelers related to attending high-risk environments.

If within the last 10 days, you have been notified by Public Health that you are a case<sup>1</sup> of COVID-19, you are required to isolate as per Public Health instructions.

• You should stay home for 14 days from the last day of exposure and monitor for symptoms. If you have symptoms, proceed to question 2.

## If you answered "YES" to any symptom:

- Stay home.
- Use the <u>AHS Online Assessment Tool</u> or call Health Link 811 to arrange for testing and to receive additional information on isolation.

If you have fever, cough, shortness of breath, runny nose, sore throat or loss of sense of taste or smell you are required to isolate for 10 days as per the current <a href="CMOH Order">CMOH Order</a> OR receive a negative COVID-19 test and feel better before returning to activities

## If you answered "NO":

• You may attend work, school, and/or other activities.
